## **PPGPL Approved Drug and Alcohol Testing Laboratories**

Dear Contractor,

Effective **01 March 2025**, PPGPL (Phoenix Park Gas Processors Limited) will adhere to the updated requirements set forth by the **Point Lisas Energy Association (PLEA)** concerning drug and alcohol testing. Test results will only be accepted from laboratory sites approved under the PLEA Drug and Alcohol Laboratory Testing Certification Scheme.

## **Purpose of the Certification Scheme**

PLEA recognizes that drug and alcohol misuse pose significant safety risks to operations. To mitigate these risks and ensure the reliability of drug and alcohol test results, PLEA has implemented a Scheme to audit and certify laboratories that meet rigorous standards.

## **Key Requirements for Compliance**

- 1. **Laboratory Certification**: All drug and alcohol testing must be conducted at approved laboratory sites listed under the Scheme. Test results from non-approved sites will not be accepted.
- 2. **Site-Specific Approval**: Approval is site-specific. Not all locations of a laboratory are certified. Contractors are responsible for ensuring that testing occurs only at an approved site.

The list of approved laboratory sites authorized for drug and alcohol testing is provided in **Attachment I**. Thanks for your understanding as we continue to aspire to maintain a safe environment for all people entering our facilities.
